Sub: **Grave consequences of inordinately delaying the payments of Consultants, and Beneficiaries being adversely impacted**

Respected Madam

Consultants are engaged by CGHS due to its abject and continuing failure to recruit MOs, and other staff. While apparently the reasons for this may be beyond the control of MOH& FW because D.O.E, what is well within their control is to ensure timely payment to Consultants who are sustaining WCs in a robust manner. **It would not be an exaggeration to mention that, but for them, functioning of WCs will virtually collapse.**

Because of delayed payments of salaries to Consultants by as much as three to four months, Consultants are getting demoralized for obvious reasons and are quitting in good numbers, effectively rendering functioning of WCs in-operational and, in the process, creating hell for the Beneficiaries..

This has naturally resulted in incredible and unexplained distress to both the Beneficiaries, and enormous stress on the existing Doctors.

Our repeated requests to the concerned authorities to ensure timely payment to Consultants, who are contributing as much as regular MOs, and are saving resources of CGHS, have been ignored and the result of this insensitivity and indifference is that Consultants, due to inordinate, unethical and unacceptable delay in their Payment, are quitting, one by one, thereby rendering WCs almost in-operational.

This callousness, insensitivity and total lack of concern of concerned authorities, who ought to be monitoring all this very closely, is just unacceptable and incomprehensible.

Needless to say, if this apathy and total lack of concern of the concerned CGHS Authorities towards Beneficiaries, who are adversely impacted due to depleted strength of doctors in WCs, continues, Beneficiaries will be constrained to come on streets to fully expose total lack of

concern of CGHS Authorities towards smooth functioning of WCs to ensure Beneficiaries are not left high and dry..

Thus, we seek your immediate kind intervention to, at least, ensure timely payment of Consultants, since regular appointment of MOs is beyond reach of MOH& FW because of unwarranted and continued scuttling of proposals of MOH& FW for approval of posts of MOs and other staff by D.O.E.
